I AGREE TO THE FOLLOWING PROVISIONS WHEN ADOPTING FROM CSI

1. I agree to make the adopted animal a part of the family. The animal will not be kept on a chain, live as an outside only animal or be given to a kill-shelter.
2. Regular post adoption checks (physical visits/video request) have to be allowed to check on the dog's condition and state of health.
3. Its mandatory to get the adopted dog sterilized within 6 months of adopting from CSI, but if for some reason (age/health/vet recommendation) the Dog has not been sterilized prior to this adoption, you agree to have the Dog sterilized in accordance to the vet's recommendation or when he/she reaches the right age.
4. I agree to keep the adopted animal under control within a secure fenced area, including shelter from harsh elements like sun, rain etc.
5. I agree not to abuse or neglect the adopted animal. If CSI determines the animal has been abused or neglected, I authorize them to remove the animal from my premises with or without involving in the process of law.
6. I agree not to abandon, give away, sell or dispose off the Dog in any way, and to notify immediately at any time I determine I no longer want to, or no longer can, keep the Dog, so that CSI can take the Dog back to make other arrangements/adoption. I agree that I will never surrender the Dog to an animal shelter. In these circumstances of me unable to keep the dog, I have to FIRST AND FORMOST notify CSI and cannot simply give away the pet to anyone else.
7. I agree to provide the adopted animal with necessary vaccinations as advised by my Veterinarian. I will obtain immediate veterinary care if the animal becomes ill or injured.
8. I understand that CSI cannot guarantee the health, temperament or training of the adopted animal, and hereby release CSI from any claim, cause of action or liability for any injury or damage to persons or property once the animal is in my possession
9. I agree to obtain all licenses required by the local government and to keep an identification tag attached to a properly fitted collar on the adopted animal.
10. If the adopted animal has behavioral problems, I agree to contact a trainer or behaviorist first, then contact CSI.

11. You agree to make a serious effort to find the Dog if it becomes lost, by immediately (a) filing lost reports with the local police, animal shelters, media and local veterinarians & pet stores, (b) posting lost dog signs (c) running lost dog adds in your local paper and (d) contacting us for additional advice and/or help.
12. Changes of address. You agree to notify us immediately if you have any change of home or business telephone numbers or residences and provide us with your new telephone numbers and addresses.
13. If any of the above conditions haven't been adhered to and the dog is found in a neglected state, the dog can be confiscated by CSI and I agree to bear the dog's expenses for transportation, food, shelter and medication as well as any other factor needed for the sustenance of the dog till the dog is rehomed; the discretion of which will remain with CSI.

Any act of inflicting unnecessary pain or suffering on animals is a punishable offence and thus, in case of extreme neglect full legal and police investigation will be undertaken as per the AWBI act.
